1. Call Select Board meeting to order

Chair Fenner called the meeting to order at 6:30 P.M.

2. Meetings are recorded

Selectperson Fenner reminded attendees that Zoom meetings are recorded.

3. Approve the minutes of March 30, 2021- Selectperson Beckett so moved, second Selectperson
Costigan

5. Road Commissioner- Jake Boyington: started grading the ridge today, some frost still but roads
are pretty good. Started getting requests for trucks or other equipment on posted roads. Will be
pulling posted signs on tarred roads possibly tomorrow, moving forward from there. Dirt roads
will take longer. Approval on entrance permit on Sennebec, were able to come to a compromise.

Motion to grant two purchase orders: Selectperson Fenner- Second, Selectperson Beckett

Purchase Order Request- Ferraiolo- \$10,000 for inch minus gravel. The cost is 16.50 a yard.

Purchase Order Request: 10,000 for ARC to haul and put down.

A. committee reports- Selectperson Beckett- Comprehensive Planning Committee met with
representative from Midcoast Planning and Development. They will bring a proposal forward
for the last Wednesday of the month Comprehensive Planning Committee meeting.

B. Approval of corrected warrant for town meeting-

The difference is that the board had previously approved placing the article regarding the Clark
Scholarship on the warrant for town meeting, it was inadvertently omitted. A vote is needed to
approve it as corrected.

Selectperson Fenner issued on an emergency basis. These are for 3 nozzles one 2.5” and one 1.5”
replacing ones that are not serviceable anymore. This is part of getting forestry trucks ready for
upcoming dry season.
Also had issued a PO for the road commissioner on an emergency basis due to the mud situation
for materials.

Selectperson Beckett- Ken Ward is on for moving speed sign.

8. Other-

Broadband Committee- Selectperson Beckett asks to reestablish the committee.
Selectperson Fenner said that it exists but no one was ever appointed.
Selectperson Beckett volunteered to be on committee.
Selectperson Fenner motion to appoint Selectperson Beckett to the Broadband Committee.
Selectperson Garrigan, second.
Discussion: Selectperson Garrigan asked what the purpose of the committee would be.
Selectperson Beckett said it was to work with Tidewater to see what could be done for further
implementation.
Selectperson Fenner said that the committee could help with a statement of support for the
broadband grant. Also a statement from the Comprehensive Planning Committee would be
helpful.
