TO: Darlene Starrett, Resident of the Town of Appleton: You are hereby required in the name of the State of Maine to notify the voters of this municipality of the election described in this warrant and notice of election.

TO THE VOTERS OF THE TOWN OF APPLETON: You are hereby notified that a Five Town Community School District referendum election will be held at the Appleton Town Office, 2915 Sennebec Road in the Town of Appleton at 8:00 A.M. on Tuesday, January 14, 2025 for the purpose of determining the following articles:

Article 1A: To choose a moderator to preside at said meeting.

Article 1: Do you favor authorizing the School Board of Five Town Community School District (the "District") to issue bonds or notes in the name of the District for minor capital project purposes in an amount not to exceed **\$7,300,000** to construct and equip the following projects at Camden Hills Regional High School:

1. Replacing the Don Palmer Field with artificial turf;
2. HVAC system improvements to replace failed geothermal system;
3. Replacement siding and windows; and
4. Strom Auditorium repairs and upgrades.

The voting on Article 1 shall be by secret ballot referendum. The polls will be opened immediately after the election of the Moderator following commencement of the meeting at 8:00 A.M. and closed at 8:00 P.M.

The Registrar of Voters will hold office hours while the polls are open to correct any error in or change a name or address on the voting list, to accept the registration of any person eligible to vote, and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.


