- VII. Road Commissioner: Storm Damage Boyington evaluated the roads after the storm
 - a. Route 105 ice dam/DOT: RT 131 ice dam reported to the state by Boyington, Boyington put out cones, signs and sand and salt, Boyington noted there was an accident at that area.
 - b. Sennebec Road ice dam/ town: Boyington evaluated town roads
 - i. Boyington will put signs on Fishtown Rd where there is a buildup of ice area

 - iii. Magog Rd, Esancy Rd and Blackberry Lane will need some gravel
